He retained that position for nearly 12 years through the subsequent mergers with Chemical Bank and Chase Manhattan. Dr. Lieberman worked intensively with the

Bank's trading operations and with the portfolio managers of some of the world's largest financial institutions and governments. During his tenure, he also served on the Bank's committee responsible for funding, interest rate and currency risk management.

As a leading economic and financial commentator, Dr. Lieberman has appeared on CNBC, CNN, and The Nightly Business Report on PBS, Reuters Financial Television, Fox Business News, Wall Street Week, and the major television networks. Bloomberg, Reuters, The Wall Street Journal, The Washington Post, Dow Jones News Service, and numerous other business publications frequently seek out Dr. Lieberman's clear interpretation on world financial events.
